By signing this agreement you are giving up certain legal rights!**

To: Wheatonriver Adventure and to her Majesty the Queen in Right of Canada, the Province of British Columbia, the Northwest Territories and the Yukon Territory.

Wheatonriver Adventure is a sole proprietorship of Carmen Muehlemann, registered in Whitehorse, Yukon, Canada. I understand that participating in any activity with Wheatonriver Adventure and / or Carmen Muehlemann involve certain dangers, not all of which can be listed here. Activities may include lake and river travel aboard motorized boat, canoe or kayak, hiking, backpacking, swimming, fishing, handling tools and fires, various winter activities, all season cabin rentals. It may also include travel during unpleasant weather conditions summer and winter; on land, water, snow and ice; and other associated activities. Our activities take part in remote and undeveloped wilderness areas with poor communication and where no rescue or medical assistance can be expected within reasonable time.

In consideration of Wheatonriver Adventure and / or Carmen Muehlemann, accepting my reservation and allowing the undersigned to use its facilities and services, the undersigned on his behalf and on behalf of his heirs, executors and administrators hereby absolutely and forever releases and discharges Wheatonriver Adventure, its employees, agents, assigns, officers, directors and independently contracted guides, from all claims of any kind whatsoever, whether at law or in equity, which the undersigned has had or now has or otherwise hereafter can, shall, or may have for or by reason of personal injury, loss of income, and all loss or damage to personal property in respect of or arising out of said use of the facilities and services including the transportation to and from facilities as well as matters relating to the undersigned activity with Whetonriver Adventure.
